he 7th edition of the Pravasi Bharatiya Divas (PBD) Convention organised by the Ministry of Overseas Indian Affairs, India in partnership with the State Government of Tamil Nadu and the Confederation of Indian Industry (CII) kicked off to a glittering start with the inauguration of the trade and industry exhibition and a cultural extravaganza on the evening of 7 January 2009. The three -day event concluded on 9 January by honouring outstanding overseas Indians with the prestigious Pravasi Bharatiya Samman Awards for their contribution to India's growth.

The President of India, Smt. Pratibha Devisingh Patil, presented the prestigious Samman Awards to 13 distinguished overseas Indians for their outstanding contribution to India's growth at

the Valedictory Session.

Earlier, on 8 January, Dr Manmohan Singh, Prime Minister of India, and Dr Kalaignar M Karunanidhi, Chief Minister of Tamil Nadu inaugurated the event.

In her valedictory address, Smt Pratibha Devisingh Patil told the overseas Indians that India is proud of their role in the growth of their countries of adoption. At the same time, India too has grown in stature, and the focus now is to expand economic opportunities and incomes for all, she observed. India now 'seeks to bridge the infrastructure gap and to achieve energy security, food security and human welfare security', she said, urging overseas Indians to invest in India, particularly in infrastructure.

The President commended the role of the 5 million overseas Indian workers and suggested that a separate award be instituted by the Ministry of Overseas Indian

Affairs to recognize their contributions to India's growth.

In his Inaugural Address, Dr Manmohan Singh said that several measures have been taken to strengthen national security. India is working with the international community to ensure that there are no 'safe havens' for terrorists, he said. Apprising overseas Indians of India's achievements, he reassured them that the fundamentals of the Indian economy remain strong and that a growth rate of 7% is expected for the year. Stating that India is actively involved in the meetings of the G-20 on a new global financial architecture, he expressed the view that a new structure must be suited to new challenges and reflect changes in the global economic structure.

The Prime Minister also launched the Global Indian Knowledge Network to serve as a virtual think tank and for sharing development ideas and knowledge of the diaspora. Three books were unveiled during the inaugural, including a photographic book on the Indian

Dr Kalaignar M Karunanidhi, welcoming delegates to Tamil Nadu, said that India's diversity had helped Indians to assimilate into other societies. He stressed that India and China are the key to revival of the global economy. Tamil Nadu, with abundant technical manpower and well-developed industrial base, could provide the lead for India in this endeavor. He urged delegates to share the potential of the State and India as an investment destination.

Mr K V Kamath, President, CII, in his vote of thanks, expressed appreciation to delegates for keeping the image of India high.

At the valedictory session, Mr Angidi Veeriah Chettiar, Vice President of Mauritius, accepted the honor of the Pravasi Bharatiya Samman Awards on behalf of all the awardees. Expressing gratitude to India for the warmth and sincerity in renewing ties with the overseas Indian community, he said that the new policies had been beneficial to pravasis as well as for India. Mr Ramdien Sardjoe, Vice President of Suriname, who also received

**India Health Summit** 



Around 600 delegates participated in the 5th India Health Summit which focused on 'Optimizing Health Delivery in India:

A Patient-centric Approach'

he 5th India Health Summit, CII's flagship event on Healthcare, with the theme 'Optimizing Healthcare Delivery in India: A Patient-centric Approach' drew international and national stalwarts from the Healthcare space. Held for the first time in partnership with the Ministry of Health and Family Welfare, the Summit, spread across two days with nine plenary sessions, attracted nearly 600 delegates both from the healthcare domain and across verticals such as Banking, Insurance, Venture Capitalists, Medical Technology including IT, and NGOs, among others.

The key findings and recommendations emerging from the discussions at the Summit centered around Healthcare Infrastructure, Healthcare Workforce, Healthcare Financing, Quality & Accreditation of Healthcare and Consumer Affordability, including Insurance. The important takeaways and recommendations from the deliberations will be submitted to the Ministry of Health and Family Welfare and the Ministry of Finance.

Addressing the Inaugural Session, Mr. Kapil Sibal, Union Minister for Science & Technology and Earth Sciences, India announced that the government is working on Medical Devices legislation, in order to standardize the quality of Indian manufactured medical devices. He emphasized on the promotion of greater R&D in the field of technology and genomics. He also highlighted target drugging, vaccinations and innovative solutions,

manufacturing and managing medical devices domestically, delivery of quality human resource and affordability, as key focus areas.

Dr. Pervez Ahmed, Summit Chairman, and Executive Medical Director, Max Hospitals Group said, "Solutions to healthcare should follow a proximity approach, and be customized to the local community. Integrating research and technology aligning healthcare delivery should be given immense importance."

"The task before us is how do we rapidly fill the huge deficit for quality healthcare, which is inaccessible to many, "stated Dr. Prathap C Reddy, Chairman, CII National Committee on Healthcare, and Chairman, Apollo

Hospitals Group. "We should look at innovative healthcare models, work on a standard definition and create a working environment for PPP. The government should now look at healthcare's requirement to quickly multiply the number of healthcare professionals in India."

Mr. Ajay Shankar, Secretary, Department of Industrial Policy and Promotion, in his keynote address at a special plenary on "Investments in Healthcare" observed that "by 2020-25, Medical Value Travel in India will stand

where India's IT sector is positioned today. India has all the intellectual capabilities, and the sector will boost up the industry. The industry with its set of progressive strategies should come up with innovative and out of the box thinking for securing investments".

One session that received an overwhelming response was 'Successful States' Healthcare Models,' with detailed presentations by Mr. P. K. Aggarwal Principal Secretary, Health Medical and Family Welfare, Andhra Pradesh, Dr. Amarjit Singh, Principal Secretary, Family Welfare & Commissioner, Health, Medical Services & Medical Education, Gujarat, and Dr S. Vijayakumar, Special Secretary, Health, Tamil Nadu.

A special session, "Health Insurance Inc - The Road Ahead" was organised based on the recommendations of the recently held Health Insurance Summit in Mumbai.

The summit concluded with a detailed presentation on the deliberations and recommendations which came out of the sessions to Dr.Anbumani Ramadoss, Union Minister for Health and Family Welfare, who was the chief guest at the valedictory session. Dr. Ramadoss, in a passionate and dedicated approach, supported industry's request for granting industry status to healthcare. He also said the government was in the process of recognizing post graduate (PG) degrees from English speaking countries like the United States, United Kingdom, Canada and Australia, apart from doubling the PG pass-out number which at present

stands at 12,000.

# The Emerging Agenda: An Update

CII's theme, India@75: The Emerging Agenda, reflects its aspiration to facilitate India's transformation into an economically vital, technologically innovative, socially and ethically vibrant global leader by the year 2022



he India@75 project has been progressing smoothly across the nation. Fourteen states have completed their State Workshops and Interviews including the State Consolidation Workshop. The total number of workshops conducted were 77 which witnessed participation of 3529 stakeholders. A total of 281 interviews have been conducted.

As a part of the India@75 initiative, select one-toone interviews/interactions have been conducted with government officials, industrialists and civil society leaders across the nation to discuss their aspirations and vision for India after 75 years of independence. A total of 18 interviews have been conducted.

A series of National Workshops are also being conducted for the CII National Committees, Councils and Task Force to discuss and finalize a list of national vision elements along with indicators / metrics to measure progress and also identify challenges towards achieving this vision.

National Workshops have been conducted for the National Committees on Rural Development; Education; Skills/ HR and IR/ER; Technology; Trade and Manufacturing Council.

The District Development Plans (DDP) for select districts in Southern States are currently under preparation. The districts selected in the Southern States are as follows:

- · Andhra Pradesh: Hyderabad, Vizag, Vijayawada, Tirupati
- Kerala: Kannur, Thiruvananthapuram, Thrissur,
- · Tamil Nadu: Chennai, Karur, Erode, Coimbatore, Madurai, Trichy



Karnataka: Bangaluru, Mysore, Hubli

In the West, DDP will be developed for Chhindwara, Madhya Pradesh.

The Vision Ambassadors' Movement, led by Young Indians has been an important arm of the India@75 initiative. Currently, 254 Vision Ambassadors are engaged across the country in spreading the message to the masses. As part of the signing up process, 57 Vision Ambassadors attended Induction and Role Selection Sessions held in Mumbai, Chennai and Delhi. At present 105 Vision Ambassadors are contributing to India@75 as Evangelists, Education Experimental Project Implementers, Next Practices Identifiers and Online Collaborators.

Many initiatives have been taken up by the Vision Ambassadors in various capacities. The Evangelists have addressed on India@75 at many internal and external platforms to ignite the momentum. The Education Experimental Project Implementers are involved in the ground project of "Getting Children to School" in various districts and cities of the country. Three out of 17 signed up projects have made considerable progress as on date. The Next Practices Identifiers are involved in shortlisting and documenting innovative, scalable, sustainable and cost effective next practices. A case study competition is being organized for students through 'Call for Papers on Identifying Next Practices'.

Students are also engaged in India@75 through activities such as the Imagine-A-Nation Campaign and Anti Terrorist Rally organised by Yi Net Students.

# Renewed Focus on Corporate Governance

cknowledging the renewed focus on corporate governance in view of recent events, Mr. Uday Kotak, Chairman, CII National Council on Corporate Governance, and Executive Vice Chairman and MD, Kotak Mahindra Bank Ltd, opined that the Satyam case is an exception, which should not question the standards of corporate governance being followed by India Inc.

Addressing a session of the CII Governance Series on 9 January in New Delhi, Mr Kotak felt that while governance may be principle based, there is a need to base it on rules and regulations that follow principles having a direct oversight by the regulators.

He attributed the current status of corporate governance in India to the shift from the previous personalized saverborrower model to the present-day impersonalized issuer-investor model – based on the sequential process of intermediaries including directors, independent directors, rating agents, auditors and lawyers who are expected to follow trust based institutionalization.

Underscoring the role of third parties in governance, he pondered over the dependability of the ratings

assigned by credit rating agencies and legal opinions issued by lawyers. Describing 'true & fair' as the central point of reliance placed by stakeholders, he highlighted the role of auditors in corporate governance. Appealing for avoidance of unconstructive interdependence amongst the third parties, he called for establishing a long-term sustainable institutionalized trust where each intermediary realizes its individual and collective accountability.

Highlighting pertinent issues encompassing form versus substance, Mr Richard Rekhy, Chief Operating Officer, KPMG raised questions on the constituents of corporate governance including board meetings and agenda

- code of conduct, ethics
- independent directors
- CEO succession and performance, and risk management and oversight

Stressing on the need for independent directors and audit committees to be truly independent with predetermined accountability, he emphasized that board oversight should clearly focus on ethics, independence and transparency.

Earlier, in his welcome remarks, Mr. Neville Dumasia, Executive Director, Governance, Risk and Compliance Services, KPMG, acknowledged CII's role as a frontrunner in the evolution of Corporate Governance in India -

> working for over a decade with a view to ensuring greater acceptability and adoption of best governance practices by the Indian Industry.

> A CII publication on transition to the International Financial Reporting Standards named 'Transition to IFRS: A Governance Perspective' was launched by Mr Kotak during the session. The CII publication is an integrated endeavor to make Directors and Senior Management aware of challenges to convergence and assist them in drawing up a roadmap to facilitate their

technical preparedness - with a focus on its impact on corporate governance. Session with Mr Adi Godrei 'Recent events in the global economic and financial

sector have led to renewed focus on the legislation and enforcement of the various constituents of corporate governance' was the sentiment echoed by speakers at the CII Corporate Governance Series breakfast session with Mr. Adi Godrej, Chairman, Godrej Group, on 18 December in Mumbai.

Delivering the theme address, Mr. Adi Godrej asserted that the need of the hour now more than ever before is concentration on principle -based, rather than rule



based, corporate governance because, during trying times like these, the temptation to deviate remains large. Principle-based corporate governance, being robust, offers corporates the much needed competitive advantage in markets, easy availability of capital, enhanced employee morale and stakeholder confidence; and long term sustainability, he said.

Identifying Corporate Governance as one of the pillars of modern successful enterprise systems leading to the overall development of the economy, Mr Godrej recognized the markets as the ultimate disciplinary authority.

Earlier, Mr. Uday Kotak said it was time to deliberate

the role, absence or failure of corporate governance globally and try and lay down lessons to minimize the consequences on the Indian economy

Mr. Neville Dumasia, Executive Director, Governance, Risk and Compliance Services, KPMG, suggested stronger regulatory review mechanism and greater disclosure and transparency of compensation for overall improvement in corporate governance.

The CII Governance Series, is an annual event of CII comprising a series of breakfast meetings with captains of Indian industry, focusing on governance, accountability, transparency, ethics, compliance and trust, towards fostering a culture of good governance.

## Interaction with UK Minister

CII organised an interaction with the visiting UK Minister, Rt. Hon. Stephen Timms, Financial Secretary to the Treasury, UK, on 11 December in New Delhi to discuss the measures required to protect the growth rate of the Indian economy in times of global financial crisis.

The Financial Secretary to the Treasury was accompanied by a team of senior diplomats including the Deputy High Commissioner of UK in India, Mr Creon Butler. The interaction afforded an opportunity to discuss the impact of the recent developments in the global financial sector on India. During the next G20 Summit in April 2009 under UK's Presidency of the G20, the way forward to deal with the current global developments would be presented.

During the last G20 meeting in Washington, the business community from the G20 countries came together to provide a five point agenda for political leaders at the Summit. CII was a signatory to that agenda. The visiting Minister was informed that CII looked forward to greater coordination among the business community to help play a supplementary role in the resolution of the crisis.

# 21st CII National Skills Competition

#### 130 competitors demonstrated their skills in 9 trades

II has been organising the National WorkSkills Competitions for the last 20 years with a view to encourage skills development and to recognize the best talent in the country. The competition is held in partnership with DGET, Ministry of Labour and Employment, Government of India.

The 21st National WorkSkills Competition 2008 was held from 15- 18 December at two locations

in Bangalore, the Foremen Training Institute (FTI) and the Regional Vocational Training Institute (RVTI). The event witnessed a great level of enthusiasm from participants from all over the country who represented their organisations for a wide range of skills. A total of 130 competitors from various organisations participated in nine trades which were divided into two categories above 22 years and below 22 years. These competitors were the winners of the four CII Regional Work Skills Competitions held in September 2008 in Chennai, Pune, Chandigarh and Kolkata.

The competition was held in nine different trades namely Electrician, Fitter, Welder, Tool & Die Maker, Machinist, Turner, Industrial Electronics, COPA and Instrument Mechanics. Fifty one competitors were adjudged the winners. In the Best Establishment category, Bosch, Bangalore, won the first prize with TATA Steel, Jamshedpur coming second.



At the awards distribution ceremony, Mr. N Reguraj, Managing Director, NTTF, urged the delegates to run an extra mile to deliver the best. Mr. B. R. Satyan, Director, C.M.T.I, emphasised on the need for good coaches to hone the skills of workers to achieve world class standards. Mr. S.J. Amalan, Director, Apex Hi-Tech Institute, reiterated that excellence can not be achieved without putting body, mind and heart together,

while Mr. Bharath Vikru, Director, Foremen Training Institute, was highly appreciative of the performance put in by the competitors, raising the standard of competition.

Mr S K Kakkar, Principal Counsellor, CII, described CII's recent initiatives with the HRD Korea and World Skills International in bringing the best practices in the world to our trainers and workmen. # **South Africa to Partner IETF 2009**

outh Africa has accepted the invitation of "Partner Country" status for IETF 2009. The 18th International Engineering & Technology Fair is being organized by CII from 23-26 February 2009 in Bengaluru. The invitation was accepted by South Africa's Department of Trade & Industry (DTI).

This is the second time that South Africa will be Partner Country at IETF 2009. The first time was in 2005 which was very helpful in generating awareness about South Africa as a producer of engineering and technology products. About 45 companies / institutions from South Africa participated in the IETF 2005. The success can be gauged from the fact that trade has doubled in three years from US\$ 3.1 billion in 2004-05 to US\$ 6.2 billion in 2007-08.

The DTI, South Africa, has identified India as a natural trade partner and has adopted aggressive marketing initiatives to tap into the large and growing Indian market and also to seek Foreign Direct Investment from India. The participation in IETF as partner country is part of this strategy. Partnering IETF 2009 will provide South Africa a unique opportunity to focus and showcase its industry, technology products and services, government initiatives, trade and investment opportunities and tourism opportunities.

The 18th IETF 2009 is structured as a comprehensive B2B event segmented into well defined sections of the engineering and manufacturing industry. These sections are represented by focused business fairs/ pavilions, namely Automation/Robotics 2009, Energy & Environment 2009, Manufacturing India 2009, ASEAN & IETF Global 2009, Partmart & Autocare 2009, Photoshop India 2009, SAFE 2009. A South Africa Day will also be organized which will include an Investment Opportunities seminar and one-to-one meetings.

India-South Africa economic relations have been growing rapidly and the momentum has especially picked up over the last five years. South Africa is India's largest market in Africa. South Africa, and, in particular, Johannesburg is the preferred location for a number of Indian companies

that have based their Africa headquarters there. The relative complementarity between the two economies is reflected in the two-way flow of FDI, with several Indian companies making sizable investments in South Africa and major South African companies doing the same in India. There is an active exchange of business delegations, and the expanding institutional framework that underpins such exchanges.

Despite the substantial increase in bilateral trade, there is a feeling on both sides that it is still well below the potential. India does not figure amongst South Africa's top five trading partners for imports as well as exports. The Joint Statement by the two sides during the visit of our Prime Minister in October 2006 has set the ambitious target of trebling trade by 2010. Both governments are taking initiatives such as PTA agreements, various agreements at industry / sectoral level, strategic level etc. to increase trade further.

IETF. a biennial flagship event of CII, organized since 1975, is one of the largest events of its kind in Asia. The fair is used as a platform by countries and companies to showcase entrepreneurial and technological expertise, and for forming strategic partnerships, business networking and international benchmarking.



oday, the railways have lost 65% of their freight traffic to the roads. The private sector should be considered as a collaborator for strengthening the system strategically, declared Mr. Rajeev Jyoti, Chairman, CII Railway Equipment Division, at the inaugural session of Rail Contact 2008; Partners in progress - Indian Railway's modernisation plan and Industry's role, held on 12 December in New Delhi. Mr Jyoti noted that in order to sustain GDP growth of 8%, the capacity and efficiency of the rail network needs to be ramped up; and approval for resources and expertise should be intensified.

The buyer-seller meet was organised towards achieving 20% of investment targets from private enterprises.

In the 10th five year plan, the private sector's participation in railways was less than 1%. It is anticipated that in the 11th plan, about 20% of railway investments will come through PPPs. Thus, out of total investments of Rs 2,80,000 crore in the Indian Railways, approximately Rs 47,600 crore is expected to be invested by the private sector.

In an appealing presentation, Mr. Siddhartha Das, Practice Leader - PPP, Ernst & Young, said, PPP addresses the investment and governance challenges of the sector. Notifying a Railways PPP Policy and setting up a PPP technical secretariat, can be treated as leading steps for the railways for achieving a world class infrastructure. Other key issues are adhering to timelines and project schedules, protection of quality standards, independent process of certification and improved services quality.

Expressing enthusiasm about the Delhi-Mumbai Rail Corridor, which is likely to be operational by 2012, Mr. J P Chowdhary, Past President, CII, and Chairman, Titagarh Wagons Ltd., stated, "In major PPP initiatives, the private sector should not be viewed as mere suppliers, but as

> associates in achieving a world class railways infrastructure. It is essential to stimulate private investment and PPP as a viable option to attract funding."

> Mr. Naresh Agarwal, Vice Chairman, CII Railway Equipment Division, said, "This is the fourth edition of this buyer-seller meet. It will identify new opportunities in the sector."

# **National Retail Summit 2008** Collaborate, not Compete: the new mantra

#### The National Retail Summit 2008 focused on 'Collaborative Retail: The New Engine of Growth'

"Cooperate not Compete", said, Mr. Kishore Biyani, Chairman, CII National Committee on Retail & Founder & CEO, Future Group at the National Retail Summit organized by CII in Mumbai on 11 December. "We operate in a new world order, wherein collaboration with stakeholders is key to profitable business and growth hereon. Areas like marketing spends, real estate, recruitment and training, sourcing, back-end and advocacy offer tremendous scope for cooperation. Ideally, we should look at collaboration on common processes that provide no competitive advantage. This alone would enable shaving off 5-8% of costs." Mr. Biyani added that, if retail as a sector is to be given a boost, there has be a shift in the way it is viewed. "Retail needs to be seen as a necessity rather than a luxury; hence it needs to be given an industry status."

Infusing an optimistic tone to the summit, Mr. V Vaidyanathan, Executive Director & Member of the Board, ICICI Bank Ltd., said, "The extent of collaboration is much higher in the last three months as compared to the last one year." On the economic slowdown and its implications, he felt, " the question should not be how to face this economic slowdown, rather it should be - are we prepared to take on the opportunities that will come after this economic phase."

Ms. Ireena Vittal, Partner, McKinsey provided valuable insights on questions such as Why Retail Industry matters

to India, What will it take to ensure the Indian retail industry succeeds, and What will ensure Indian retail industry's success.

The Retail industry matters to India, she said, because

1. It is a catalyst that converts consumer confidence into consumption;

oxygen for Indian economic growth: 68% of GDP growth is from private consumption. Private consumption is the biggest hope for the Indian retail industry because Indian consumers have big dreams and higher disposable income, and jobs and employment are still stable.

- 2. It creates jobs that are essential to channelise youth energy: India is a young country and the working population will keep growing, thus we need to create 20 million jobs each year. Every job in retail creates 7-9 jobs in the support infrastructure.
- 3. Triggers for an efficient economy:
- Multiplier effect
- Improves productivity, reduces inflation
- Higher tax revenues

Three critical enablers for retail success in India, she said, are,

- 1. Shared understanding of success amongst the various stakeholders in the retail industry
- 2. Seamless collaboration across the entire value chain
- 3. Building critical capabilities to ensure profitable growth and flexibility

To ensure success, the Indian retail industry, Ms Vittal suggested, must create a common agenda:

Get government to declare retail as an essential service

- City master plan designs to include
- Licensing simplified single window clearance
- · Reference case of 3 big suppliers as category captains
- · Win-win terms of trade with real estate
- Roadmap for 20 vendors to scale up 10 times in the next 5 years across retail

- To manage critical costs (power, service tax, etc.), retailers need to collaborate at the back-end, compete in front
- Common supply chain for sourcing in specific categories
- Manage promotion intensity in the market
- Joint investment in training capabilities and building core capabilities
- Clarify pricing and develop core merchandise platform
- Define differentiated supply chain.

Concluding the summit, Mr. Pradipta K Mohapatra, Immediate Past Chairman, CII (SR) & Chairman -Governing Board, Executive & Business Coaching Foundation India Ltd. stated that, "Collaborative Retail is what will make the retail industry gallop to further growth."

The day long summit presented the views of several industry stalwarts including Mr. Ajit Ranade, Chief

Group Economist, Aditya Birla Group, Ms Roopa Purushothaman, Chief Economist, Future Group, Mr. Abheek Singhi, Partner, BCG India, Mr. Aniruddha Deshmukh, President, Retail & FMCG, Raymond Ltd., Mr. Ajay Kaul, CEO, Domino's Pizza India, Mr. Atul Goel, Managing Director, E-City Ventures, and Mr. Vinod Sawhny, President & COO, Bharti Retail Pvt. Ltd. There was also a special address on 'Prognosis of consumer demand' by Ms. Rama Bijapurkar, Independent Management Consultant and author of 'We are like that only - Understanding the Logic of Consumer India.'

The CII National Retail Summit, by focusing on Collaborative Retail, captured the need to build a collaborative platform with all stakeholders in the consumption and retail ecosystem, including retail real estate and infrastructure development, supply partners, technology partners, logistics and supply chain partners and consumer groups.

he Confederation of Indian Industry organised its annual conference: 'India-The Big Picture' in partnership with the Ministry of Information & Broadcasting on 22 November in Goa. The conference, focusing on "New Dreams, New Directions" coincided with the 39th International Film Festival of India (IFFI). CII has been organizing this Conference for the last four years to facilitate the growth and development of the Indian film industry.

Mr Anand Sharma, Minister of State for Information & Broadcasting and External Affairs, while inaugurating the conference, felt that India, with its bountiful creative and technological talent, can become a hub for outsourcing as well as making and exporting original animation films to other parts of the world. Mr Digambar Kamat, Chief Minister, Goa, who was the Guest of Honour, said that the brand name of Goa for international film festivals is fast catching up. He said that an ideal location for establishing world class

# Conclave on School Excellence

A Conclave on School Excellence explored the transition from 'Best' to 'Next' **Practices** 



he CII Institute of Quality, Bangalore, along with CII Coimbatore Zone organised a two day 'Conclave on School Excellence - From "Best" to "Next" Practices' on 26 -27 November in Coimbatore.

"School education needs leaders who can create change and set an example for others to follow" said Mr C N Ashok, Chairman, CII Coimbatore Zone, in his keynote address. "If there are change creators, then change seekers will follow, if there are change seekers, change will happen. More often than not, change gets a lot of resistance initially, but that's the only way to reach from best to next practices. Next practices in in school education sector will go a long way in addressing many of the problems we have today, " he said.

A panel discussion on "Changing Paradigms in School Education - The Stakeholder perspectives" generated many ideas on understanding the future paradigms and stakeholder expectations from school education.

It was well established that the tools and skills of TQM such as group problem solving, process thinking, planning, data gathering and analysis as well as listening, preventing and resolving conflict, and building cooperative relationships in schools can empower teachers to discover the hidden talents in students.

'Clustering' is a popular approach followed by industries in India. Applied to educational institutions, the School Excellence Clusters concept is a group of 10-12 institutions / schools which work together towards improving their practices and performance, through mutual sharing and learning. These schools could be from the same board, location, management and share common philosophy. They develop and follow a commonly agreed roadmap for moving towards excellence. CII IQ has initiated many such clusters at various locations including Coimbatore.

Some the key learnings from this conclave :

- Collaborate with the community, industry, alumni and other schools for creating an environment for cross learning

The maiden conclave offered dynamic learning and networking opportunities to over 120 administrators, management committee members, principals and teachers from government, corporation and private schools, NGOs and corporates across Tamil Nadu.

# **New Version of ISO 9001**



he fourth edition of the immensely popular ISO 9001 Standard has recently been published by ISO, the International Organisation for Standardisation. ISO, an association of approximately 157 members, each representing one country, develops International Standards.

The ISO 9000 standards are a collection of formal International Standards, Technical Specifications, Technical Reports, Handbooks and web based documents on Quality Management. There are approximately 25 documents, with new or revised documents being developed on an ongoing basis. Among these, only ISO 9001 contains normative requirements, which on demonstration can qualify an organization to be independently certified. Other Standards, important ones being ISO 9000 and ISO 9004, are guidance documents on quality management systems.

ISO 9001:2008 has been developed to introduce clarifications to the existing requirements of ISO 9001:2000 and to improve compatibility with ISO 14001:2004, the normative standard for environmental management systems.

First published in 1987, the ISO 9001 Standard has undergone several changes over the years, including the Eight Quality Management Principles, concept of 'Process approach', and the Plan Do Check Act Cycle.

In the normal course, all ISO documents are required

to be reviewed periodically and if required, revised. The process must begin three years after publication. Wide scale user inputs and surveys are conducted to decide on the nature and type of changes to be made. In the case of ISO 9001:2008, the need emerged for an amendment, provided the impact on users would be limited, and that changes would only be introduced when there were clear benefits to users.

ISO has clarified that ISO 9001:2008 does not introduce additional requirements, nor does it change the intent of the ISO 9001:2000 standard. However the changes have been made to improve both the understanding of the intent as well as level of compliance. Some of the key changes are:

- The term 'conformity to product requirements' has been added at several places to clarify that management of the systems and processes are not the end in themselves but the means to achieve product standards and customer satisfaction.
- The term 'statutory' has been added to 'regulatory' signifying that both types of legal obligations
- Whenever an organisation outsources any activity or part of its business, it is now obligatory to exercise control on these to maintain product conformity.
- Controls on the processes should be decided based on their impact on the product conformance.
- Whenever an organisation takes corrective or preventive actions, it now has to ensure that these actions have a lasting impact. Internal audits would now require verification of the lasting impact.
- The Management Representative, the key person who manages the quality system, should be from the organization's own management.
- IT based processes and information need to be managed and controlled both as part of infrastructure and equipment, as well as in terms of resource.
  - · Customer measuring and monitoring can be done in several ways as long as the information can be analysed.
  - The purpose of training is to achieve the level of competence required to do a job, the main emphasis being on achieving competence.

ISO has clarified that certification to ISO 9001:2008 is not an "upgrade", and organizations certified to ISO 9001:2000 should be afforded the same status as those who have already received a new certificate to ISO 9001:2008.

#### **CII Webinars**

The CII Institute of Quality, in partnership with the British Standards Institute, who hold the Secretariat to the ISO Subcommittee that has prepared ISO 9001:2008, is conducting Webinars (internet based seminars) in which the changes are explained through presentation and audio commentary followed by live interactive sessions.

Both the content of the Webinars and the format have received very favorable response.

The objective of the Mission is to promote and champion conservation of natural resources in Indian Industry without compromising on high and accelerated growth.

As a first step, a CII - Code for Ecologically Sustainable Business Growth has been developed.

Explaining the purpose of the Code, Mr G V Prasad, Executive Vice Chairman & CEO, Dr Reddy's Laboratories Ltd, said the CII Code, a set of ten natural commandments, was developed to involve top management and seek voluntary commitments from member companies to reduce their consumption of natural resources without compromising on business growth.

Mr. Prasad explained that the CII Code would focus on energy intensity reduction, decrease in water consumption, greenhouse gas (GHG) emissions intensity reduction, reduction in waste generation, utilisation of renewable energy, increased rainwater harvesting, green procurement, life cycle analysis, clean technologies, product stewardship and reduction in consumption of other natural resources like paper and wood.

At the CEOs Meet in Hyderabad, 20 companies signed the Code, taking the total number of signatories to 165.

Mr Utpal Sen Gupta, Chairman, CII Andhra Pradesh & President, Agro Tech Foods Ltd called on all companies to place environmental sustainability at the centre of their business strategies.

#### **Energy Summit**

The 8th edition of the flagship Energy Summit 2008, an International Conference & Exposition for all key stakeholders of the energy sector, was held from 8-10 December in Chennai.

In his special address at the inaugural session, Mr Mohan Verghese Chunkath, Tamil Nadu Energy Development Agency said Indian Industry can save upto 27% power by adopting energy efficient technologies and practices. Solar thermal energy was an opportunity for cost effective clean power generation, he felt, while pointing out the various barriers to cost efficient power generation, such as lack of information on how to save energy, lack of capital, infrastructure, and price and policies.

Mr Shiv Das Meena, Executive Director, Tamil Nadu Electricity Board, in his special address said the Tamil Nadu Government has various power projects in the pipeline like the Kundankulam project which is likely to be up by 2009.

C R Narayana Rao Architects & Engineers, spoke of the imperative to embrace green building practices and technologies. "Energy efficiency is intricately connected to building design, water usage, and occupant comfort and so on. A holistic approach to building design, construction and operation

is necessary to minimize energy consumption of buildings," he said.

Certified green buildings save 30 to 40% energy compared to other new buildings. The current growth in green buildings is not a short-lived trend, but the beginning of a steady shift towards green practices in the construction industry, he observed.

Mr Manikam Ramaswami, Chairman, CII Tamil Nadu & Chairman & Managing Director, Loyal Textile Mills Ltd, described Energy as the major infrastructure for the growth of the economy. The total world consumption of marketed energy is projected to increase by 50 percent from 2005 to 2030, he said, particularly in China and India.

"CII has been pursuing the energy

efficiency movement in the country for a long time and have initiated various initiatives like energy audits, energy awards, green building movement, and quality movement and sustainability services for the Indian industry", added Mr Ramaswami.

Energy Efficiency in Electrical Systems: The focus was on latest technologies in motor, transformer, VFDs, thermography application for electrical safety and industrial lighting controls

Encon in Compressed Air Systems: The session focused on advanced controls and energy saving opportunities in compressor and compressed air systems.

#### Green Architecture Award for CII

The CII-Sohrabji Godrej Green Business Centre is India's first LEED (Leadership in Energy and Environmental Design) Platinum rated Green Building outside of USA and the third in the world.

Essentially, LEED rating buildings incorporate environment- friendly features which include preservation and reuse of fertile top soil; reduced building footprints; central courtyards; day lighting; ventilation; roof gardens to reduce heat-island impact; use of treated grey water for irrigation and air conditioning cooling water makeup; root-zone treatment for wastewater; efficient envelope; use of energy efficient air-conditioning systems; on-site renewable energy; wind towers; monitoring procedures, post-occupancy; careful handling of construction waste; use of materials with recycled content; resource reuse; use of paints, sealants, adhesives with low VOC and resource reuse.

The tangible benefits of green buildings include 50% savings on energy consumption; 30% savings on potable water use & operational savings right from day one. Intangible benefits include higher productivity (10-15%) as compared to regular buildings and a 'green' corporate image.

Currently, over 375 green buildings with a footprint of over 260 million sq.ft are being constructed all over India, including corporate and government offices, IT & ITES parks, airports, banks, hotels, convention centres, and residential complexes.

These individuals will receive special training interventions to bring their skills and knowledge at par with the rest of their sighted colleagues; after the training, they will be provided the same incentives, compensation and avenues to grow. Whenever and wherever needed, we provide aids and help to enable our people. This kind of healthy and competitive atmosphere ensures that all our employees have a sense of self esteem.

With a workforce of 38 disabled employees we are building an environment where every employee is important and is valued for his/her contribution and sincerity to the organisation. We support our employees to overcome their physical disabilities and enable them to perform to their optimum. We try to ensure that a person with a physical disability is not inconvenienced unnecessarily and try to enable him or her where ever possible; without infringing on his or her privacy, self-esteem or confidence.

Our Head of Internal

Communications and Corporate Sustainability, has a 17-inch congenital shortening by birth and walks with the help of a prosthetic appliance. This has never stopped her from performing; nor has it ever crossed our minds that it will in any way inhibit her performance. However, she, like all other employees, is well aware that, should she need assistance in overcoming any physical problem, she can approach anyone in the organisation.

Hence, as an organisation, we are sensitive but do not sympathise because we feel that sympathy hurts people's self esteem. Our focus is on abilities and on supporting efforts to help overcome any physical problems. We aim to provide a level playing field for a healthy organisation that respects human disparities; be it race, creed, colour, religion, sex or physical disability.

Real contribution comes when communities are enabled for a sustained developmental impact, by empowering people, educating them, giving them instruments of income, a feeling of self-respect and a reason to live happily and healthily. #### **Dependence on Foreign Trade**

China's reliance on foreign trade has exceeded 60%, which made the country more sensitive to price changes in international markets and caused the ensuing externaldriven inflation in the nation.

#### **RMB for Forex Reserves**

China's currency, Renminbi (RMB), is likely to join other international currencies to be used for forex reserves by other economies, according to Mr Wu Xiaoling, deputy head of the financial and economic committee under the top legislature.

#### **Interest Rates Cut Again**

The People's Bank of China has rolled out the fifth interest rate cut in four months, effective from 23 December, in its latest attempt to shore up investment and boost the economy. Analysts estimate the move will free up another \$43 billion for possible lending.

#### **30th Anniversary of Reforms**

China celebrated the 30th anniversary of its reform and opening up drive, which turned the once poverty-stricken country into one of the world's largest economies. Top leaders, including President Hu Jintao, attended the ceremony on 17 December. During the last 30 years, China's GDP kept growing at an annual rate of 9.8%, more than three times the world average.

#### **New Poverty Line**

The new poverty line adopted by the government has increased the number of poor people to 43.2 million, according to Caijing magazine. The government has raised the threshold to consider a person earning less than 1,067 yuan (\$156) a year as living below the poverty line.

#### **WTO Appeal Lost**

China has lost an appeal at the WTO in a dispute over the duties it levies on car parts, marking its first defeat in a WTO dispute since joining the global trade body in 2001.

#### China - Taiwan Transport Services

The Chinese mainland and Taiwan started direct air, sea transport and postal services on 15 December, the latest step to further improve the once strained ties.

#### **Toyota Recalls Vehicles**

Toyota will recall 12,1930 vehicles in China to fix a problem that could cause drivers to lose steering control.

#### General Tariff Level at 9.8% in 2009

China would keep the country's general tariff level at 9.8% next year, the same as in 2008 and 2007. China has lowered import tariffs on five commodities, including fresh strawberries, from I January. The tariff level for farm produce will be maintained at 15.2% and that for industrial products at 8.9%.

#### **Export Tax Rebates for Steel, Machinery**

China is considering increasing export tax rebates on certain steel products to help the industry, one of the worst hit by the growing international financial turmoil. China has also increased the export tax rebates for 553 high-tech and high value-added mechanical and electrical products machinery products to alleviate cost burdens on exporters.
