The world economy is experiencing a marked slowdown, the third consecutive year of sluggish growth momentum, projected at 3.1 per cent in 2024. India stands resilient as the fastest-growing large economy for the fourth consecutive year, with an expected growth rate of 7.2 per cent in 2024-25. India's economic resurgence has emerged as a beacon of hope and opportunity, driven by the collective efforts of the Government, Industry, academia, and society.

As a key pillar of the Indian economy, Industry across sectors is positioned beyond being an engine of commerce to act as a dynamic catalyst of change. India Inc. is weaving a narrative of inclusive growth, empowerment, opportunity for all, and sustainability actions.

Indian businesses are increasingly focusing on R&D, innovation and new entrepreneurship, as well as leveraging global opportunities. Sustainability has emerged as a key preoccupation for Indian Industry as a business strategy.

CII during the year would step up its policy advocacy through analytical and data-based recommendations, developed with inputs from its members and other key stakeholders. CII's policy work cuts across overarching issues such as ease of doing business, infrastructure creation, financial sector, exports, and state-level business ecosystems, among others.
