1. Executive Summary

Myanmar, strategically positioned between the economically vibrant South Asian region and the dynamic South-East Asian economies, has long been considered as one of the most promising emerging economies in Asia. Endowed with abundant natural resources, precious stones and gems, timber and forest products, and hydropower potential, Myanmar has the potential to become a middle-income economy.

After Myanmar gained independence, the country faced long periods of political instability hindering its economic progress. In 2011, when President Thein Sein's government came to power resulting in Myanmar's transition from a military dictatorship to a military-civilian-led government, a five-year plan targeting an annual growth of 10.5% per fiscal year was launched by the government. This was followed by unfolding of major domestic economic reforms to rekindle economic growth. The country's investment laws were overhauled leading to a considerable rise in foreign investment flows from about US\$ 300 million in 2009–10 to nearly US\$ 20 billion in 2010–11.

Economic liberalisation has put the Myanmar economy on a higher growth trajectory, with GDP consistently growing at over 6% since 2011. Myanmar's GDP rose sharply from 5.65% in 1997 to 11.34% in 2000 and 13.57% in 2005, before stabilising between 6% and 7% during the period 2015–17. Although Myanmar's economic growth continues to remain strong by regional and global standards, it has slowed down since 2015. The gradual dip in growth rate since 2015 is mainly attributed to external headwinds, internal political conflicts and delays in the implementation of some reform policies. According to the World Bank, Myanmar's economy grew at 6.8% in 2017–18, led by strong performance in domestic trade and telecommunications, but offset by slowing growth in manufacturing, construction and transport sectors.

The World Bank further projects real GDP growth to moderate to 6.2% in 2018–19. The Myanmar Economic Monitor released by World Bank for December 2019 paints a positive GDP growth outlook for the economy, notwithstanding the trade and fiscal deficits. Economic growth is expected to reach 6.4% in 2019–20 and 6.6% in 2020–21 bolstered by growing investment in the transport and telecommunications sector and planned infrastructure spending by the government before the 2020 elections. Increased private participation in the growth process will continue to galvanise the country's economic growth. Driven by healthy growth rates in the early 2000s, Myanmar's per capita GDP measured in current US\$ increased by over five times during the period 2005 to 2017, registering a CAGR of 14.62% during the period 2005–17.

As regards the economic structure of GDP, agriculture still dominates Myanmar's economy. Around 45% of Myanmar's GDP comes from this sector. The majority of the country's employees (70%) work in agriculture. For sustained GDP growth, Myanmar will need to undergo a structural transformation from an agrarian economy to one based more on manufacturing and services. Modernising the agricultural sector by building linkages to complementary non-agricultural activities will likely hasten the process of structural transformation.

The Government of Myanmar announced an initial stimulus package to mitigate the impact of COVID-19 pandemic on the country's economy. This includes easing deadlines for tax payments and tax exemptions for Myanmar-owned businesses adversely impacted by this global pandemic. The government has also announced the creation of a COVID-19 fund with 100 billion kyats (nearly US\$ 70 million) to assist garment and manufacturing sectors, hotel and tourism businesses, as well as MSMEs owned by local businessmen. The interest rate on loans provided by the fund will be only 1% with a loan period of one year with the rate and period subject to review later after an accurate assessment of the economic impact of the virus outbreak.

Myanmar's total population, estimated at 53.9 million in 2018 (about 0.7% of world population), is projected to reach 63.57 million by 2050. The total population grew at a CAGR of 0.87% during the period 2000–2018; the estimated CAGR is likely to reduce to 0.65% over the period 2000–2050. This is attributed mainly to reduction in fertility rate in Myanmar from 6.1 births per woman in 1960, to 4.9 births per woman in 1980, 2.9 births per woman in 2000 and 2.2 births per woman in 2018.

Myanmar has witnessed progressive urbanisation of its population from 14.7% in 1960, 19.3% in 1980, 24.4% in 2000, to 33.8% and 36% in 2015 and 2018, respectively. The urban population in Myanmar increased from 4.03 million in 1960 to 7.99 million in 1980, 12.45 million in 2000, 14.48 million in 2010 and 16.18 million in 2018, registering a CAGR of just 1.3% during the period 2000–2018. The Myanmar government has initiated steps to augment urban infrastructure, especially in its largest city, Yangon. The Yangon Region Investment Committee has outlined the sub-centres, new towns, railway stations and industrial zones that will be established as part of the new urban development plan. With urban areas seeing accelerated economic activities and industrialisation, there are likely to be increased sectoral opportunities in infrastructure including housing; retail and consumer products, transport infrastructure, telecom services, education, healthcare services and financial services.

Myanmar exhibits a healthy demographic trend with 68% of the population falling in the working age bracket of 15–64 in 2018. Population growth in this age group recorded a CAGR of 2.5% during 2000–2018, as against a CAGR of 0.03% for the 0–14 group and 1.62% for the age group above 65 years over the same period. The 0–14 age group has not grown at the same pace as the working age group, and that presents the government an opportunity to upgrade the education, healthcare and other basic services targeted at this age group. An increasing working-age population will induce domestic demand for skills development, consumer retail services, FMCG and consumer goods, automobiles, real estate, telecom services and financial services.

Against this background, CII has prepared this detailed report on Myanmar's import profile providing in-depth insights into Myanmar's import basket. Besides attempting to provide an overview of Myanmar's economy in terms of its key fundamentals, this report highlights sectors that offer advantages for Indian exports to Myanmar by performing a detailed analysis resulting in shortlist of products that hold potential for Indian businesses to export to the country.

This report comes at an opportune time when the world is passing through a challenging period due to the spread of COVID-19. With investment activity being completely stalled at the moment and demand for FDI significantly impacted given the global moratorium on travel, this immediately calls for scouting for export opportunities for Indian businesses. Moreover, the COVID-19 outbreak has resulted in supply disruptions particularly from China. According to the UNCTAD report on *Global Trade Impact of COVID-19 Epidemic*, about 20% of global trade in manufacturing intermediate products originated in China (up from 4% in 2002), thus making it the main supplier of intermediate inputs for manufacturing companies abroad. This reduction in Chinese imports of commodities offers opportunities for Indian exporters to step up and fill in the gaps created by disruption in China’s exports.

In light of this, this report aims to facilitate identification of products offering export opportunities for Indian businesses in Myanmar. It intends to put in place a clear framework for unlocking business potential for Indian exporters.

2. Top Imports, CAGR and Countries

Merchandise and services trade have started to play an increasingly important role in contributing to Myanmar’s economic growth. According to the World Bank, in 2017, Myanmar’s trade to GDP ratio was 47.95%, up from 42.26% in 2013. The export and import of goods and services account for a lower proportion, viz., 20% and 28% of the country’s GDP, respectively, thus indicating further scope for trade-oriented growth in Myanmar.

The primary objective of this paper is to undertake a deep-dive analysis into the country’s import basket so as to understand the export potential for Indian industry.

To begin with, the table below provides a list of the top 25 imports by product by Myanmar over the period 2014–18, and the imports’ compound annual growth rate (CAGR).

Going by the imports' CAGR of the top 25 import products listed above, it emerges that Myanmar shows some fairly big numbers on either side, ranging from 575% to -38%. By-and-large, the categories with low/negative imports' CAGRs include some refinery products, auto sector products, infrastructure equipment and plastic polymers; on the other hand, categories with high/positive imports' CAGR include the categories of industrial equipment, agro products, a category of auto sector products, telecommunications equipment, textiles, fertilisers, aviation, and petroleum and gas exploration equipment.

The analysis below provides a list of top exporters for each of the top 25 products so as to provide a comprehensive overview of Myanmar's import profile. The analysis also examines India's exports of these products to Myanmar (if any) and the tariff levied by Myanmar on the import of these products.

Combined with the imports' CAGR above and the overview below, it is hoped that certain specific products are highlighted in which India can look at expanding exports, increasing its share in the overall export basket of Myanmar.

Medium oils include products such as diesel; this product category is the top import item for Myanmar with its imports worth US\$ 2,491 million in 2018, significantly higher than the second-largest import item of which US\$ 1,367 million was imported in 2018. However, the imports' CAGR of this product category is low at 3%; this could indicate either slowing demand, or, ability to produce this product category domestically.

In either case, India is a major exporter of this product category to Myanmar at no. 3. Even globally, India is a leading exporting country of this product category, with a rank of no. 5 and exports worth US\$ 32,004 million in 2018.

The difference between Singapore's exports (US\$ 2,088 million) to Myanmar when compared with Thailand (US\$ 129 million) and India (US\$ 111 million) is likely there as Singapore has comparatively little domestic consumption and, therefore, most of its refinery products are exported.

With an imports' CAGR of 31% for the period 2014 to 2018, the second crude oil product category (light oils such as petrol and ATF) is exhibiting strong and steady growth. India is already a major exporter of HS Code 271012, with a rank of no. 3 and exports worth US\$ 36 million. Once again, Singapore has strong lead over Malaysia and India in the exports of this product category. Globally too, India is a strong player, ranked at no. 6 and exports worth US\$ 14,740 million in 2018.

Myanmar has a strong imports' CAGR of 29% for the period 2014 to 2018 for HS Code 551449 and India is ranked in the top 10 countries that export this product category to Myanmar. Though the tariff rate is on the higher side, at 15%, there should be a concerted effort by Indian industry to increase exports of HS Code 551447 to Myanmar and to bridge the gap with top exporter China. *See list of Myanmar importers of HS Code 551449 in Annexure 1.*

India is already the second-largest source country for Myanmar for imports of HS Code 170199; however, there is scope for Indian producers of this product category to garner a larger share of imports and to close the gap with the leader Thailand. Globally, India is ranked no. 4 with exports worth US\$ 856 million in 2018; here, too, Thailand is the leader by some distance. Moreover, given the extremely-strong imports' CAGR of 96% for the period 2014–18, there should be greater focus on increasing exports of HS Code 170199 to Myanmar. *See list of Myanmar importers of HS Code 170199 in Annexure 2.*

Though Myanmar has a very low imports' CAGR of 2% for the period 2014–18 for HS Code 151620 and is, therefore, not a priority sector for exports, the more-interesting story is India's falling in-and-out of favour as a source country for Myanmar for this product category. For instance, Myanmar imported US\$ 14 million worth of this product from India in 2014, which was followed by a dip to US\$ 8 million in 2015, an increase to US\$ 17 million in 2016, then a low of US\$ 3 million in 2017 and, finally, nil imports of this product category from India in 2018.

Also, if we examine India's record vis-à-vis exports of this product category globally, it emerges that India was ranked no. 8 with exports worth US\$ 76 million in 2018. Most of India's exports in that year went to the Netherlands (US\$ 15 million), Japan (US\$ 10 million) and the US (US\$ 9 million). A further analysis may, therefore, be needed to ascertain the reason for fluctuating and low exports to Myanmar.

Myanmar has a modest imports' CAGR of 12% for the period 2014–18 for HS Code 300490. India completely dominates its imports of this product category; therefore, the only takeaway for the moment is that India should maintain its leadership position going forward. Globally too, India is ranked high at no. 10 with exports worth US\$ 10,742 million of this product category in 2018. See list of Myanmar importers of HS Code 300490 in Annexure 3.

Products under this category include rigs and platforms deployed for extraction and processing of crude oil and natural gas. Since India does not have any indigenous manufacture of this equipment, there are, therefore, no exports of HS Code 890520 by India. So, while Myanmar has a stupendous imports' CAGR of 253% for the period 2014–18 (owing to it being a major resource country for crude and natural gas), there is no potential for exports for India. *See list of Myanmar importers of HS Code 890520 in Annexure 4.*

Given the very low imports' CAGR of 1% for the period 2014–18, HS Code 871120 is not an attractive product category from the perspective of exports and slowing demand of motor vehicles of this particular cylinder capacity is the most likely reason for this low imports' CAGR. India is already a top sourcing country for Myanmar for this product category and, therefore, any effort vis-à-vis this product category would have to focus on increasing India's share from the current US\$ 5 million. Globally, India is the second-largest exporter of HS Code 871120 with exports worth US\$ 1,931 million in 2018, with the top countries being Bangladesh (US\$ 282 million), Sri Lanka (US\$ 225 million) and Nigeria (US\$ 220 million). *See list of Myanmar importers of HS Code 871120 in Annexure 5.*

While India is ranked no. 6 for Myanmar and no. 4 globally as a source economy for HS Code 870410, the demand for dumpers for off-highway use is petering off very sharply in Myanmar — from a high of US\$ 955 million worth of imports in 2015 to US\$ 257 million in 2018. India has an opportunity to increase its share in this product category's imports by Myanmar as it already in the top 10 source countries and because of the fact that its export numbers went up from US\$ 0.64 million in 2017 to US\$ 6 million in 2018. Moreover, with a strong imports' CAGR of 36% for 2014–18, this product category offers scope for increasing exports' share in spite of a high tariff rate of 14.9%. This product category is not an attractive item as its imports' CAGR for 2014 to 2018 was -3%; the import demand has been steadily falling, though India's exports of the product category have shown an increase from US\$ 4 million in 2017 to US\$ 9.7 million in 2018. Therefore, there is a possibility for India to increase its share by moving up the ranking, but not per se if import demand is taken into consideration. The imperative here is clear — India should focus on improving its ranking as a source country for Myanmar for HS Code 871110 to close the gap with the top 2 leading countries. Myanmar has a very strong imports' CAGR of 79% for 2014–18 and given India's established strength in the manufacture of this product category, there is immense scope for consolidating India's exports further. India has a global rank of 13, with a surge in exports from US\$ 0.36 million in 2017 to US\$ 8.6 million in 2018. *See list of Myanmar importers of HS Code 871110 in Annexure 11.*

India's exports of HS Code 230990 to Myanmar have the potential of growing further given the fact that the top 2 sourcing countries are geographically distant; in any case, the gap between India and Brazil is minuscule and with an imports' CAGR of 87% for 2014–18, there is a definite case for increasing exports of this product category.

Though India ranks no. 5 as a source country for Myanmar for HS Code 190190, India's exports of this product category to the country have fallen during the period 2014–18, from US\$ 1.6 million in 2014 to US\$ 0.63 million in 2018. Therefore, even though this product category has a strong imports' CAGR of 27% for the period 2014 to 2018, the quantum of exports has fallen and further analysis should be undertaken to ascertain the reasons.

India does not export this product category to Myanmar though it has a high imports' CAGR of 63%. Though Myanmar has a steady and strong imports' CAGR for HS Code 310560, India is not well-placed to increase exports of this product category given the paltry exports achieved in 2018, a fall from the already-low figure of US\$ 66,000 in 2014. India's exports of HS Code 851718 to Myanmar have fallen steadily in the period under consideration, from US\$ 1.8 million in 2016 to US\$ 5,87,000 in 2017 and US\$ 3,28,000 in 2018.

So, while Myanmar exhibits a healthy imports' CAGR of 41% for the period 2014 to 2018, there appears to be an erosion of India's share of this import basket and, therefore, little potential to increase exports of HS Code 851718 to Myanmar. With a substantial imports' CAGR of 113% for 2014–18 and a massive gap between India and the no. 1 source country, there is immense impetus for India to garner a bigger share of Myanmar's imports of HS Code 851762. In fact, India's exports of this product category to Myanmar have been on an upward trend, with exports worth US\$ 37,000 in 2014, US\$ 0.20 million in 2015, US\$ 0.27 million in 2016, US\$ 1.5 million in 2017 and US\$ 3.2 million in 2018. Though India is in the top 10 list of sourcing countries for Myanmar for HS Code 551319 and the product category has a very impressive imports' CAGR of 104% for 2014–18, the quantum of Indian exports of this product to Myanmar is fairly low. India's exports of this category to Myanmar touched a high of US\$ 6,66,000 in 2015 and have not shown much potential for

growth; additionally, there is a fairly high tariff rate on this product category. Myanmar's use of wheat and meslin seems to have imploded with imports rising from US\$ 1 million in 2014 to US\$ 17 million in 2017 and to US\$ 102 million in 2018, which is reflected in its imports' CAGR of 218% for 2014 to 2018. However, and though India is ranked no. 10, there is no potential for India as last-reported export figure was an abysmal US\$ 8,000 in 2017. In addition, globally too India is ranked low at 30 with exports falling from US\$ 152 million in 2015 to US\$ 46 million in 2018. A drastic reduction in imports of HS Code 842959 resulted in an imports' CAGR of -20% for 2014–18. Also, India's exports of HS Code 842959 to Myanmar have seen a steady decline during the period under consideration, from US\$ 7.4 million in 2014, to US\$ 5.5 million in 2016 and US\$ 2 million in 2018. So, though India is ranked very high at no. 3 globally in terms of exports of this product category (US\$ 227 million in 2018), for Myanmar there appears to be little potential given the tapering off of import demand. *See list of Myanmar importers of HS Code 842959 in Annexure 20.*

With a massively-negative imports' CAGR of -38% and a tariff rate of 23.0%, the export market for HS Code 870323 in Myanmar appears to be closed for business. Though India's exports of this product category to Myanmar have shown steady growth from US\$ 2,000 in 2014 to US\$ 4,67,000 in 2016 and US\$ 9,10,000 in 2018, the overall slowdown in imports implies an extremely-limited market for this product category in Myanmar.

Once again, this is a product category in which the imports' CAGR is extremely high at 575% and India is ranked no. 3; however, India's exports are very low in terms of absolute numbers and have shown some fluctuation during the period under consideration, from US\$ 0.42 million in 2017 and then falling to US\$ 0.080 million in 2018.

Therefore, if Indian industry is to increase exports of this product category and garner more share, a further analysis would be needed to ascertain the low number and also the immense gap between the top 2 source countries and other exporting nations. Globally, India is ranked rather low at 38 with exports worth US\$ 27 million in 2018. See list of Myanmar importers of HS Code 730661 in Annexure 22.

3. Balance of Trade, Product-Wise

Analysing the balance of trade (BoT) indicates the attractiveness of a market from the perspective of participation in trade fairs. For the purposes of this report, the BoT is calculated at the product level, rather than for the country per se; such an analysis indicates if a particular product is being imported for domestic consumption, or whether it is being imported to enable re-exports after either value-addition or to take advantage of FTAs.

Typically, a market with a negative BoT is one where the product is being consumed domestically and, hence, Indian companies should attend B2C trade fairs in Myanmar for these products; on the other hand, attendance in B2B trade fairs is recommended for products wherein Myanmar has a positive BoT. The BoT for the top 25 products imported by Myanmar is as follows:

Therefore, what emerges from the above analysis is that HS Codes of 14 products viz. 271012, 551449, 170199, 300490, 722830, 210690, 871110, 230990, 190190, 851718, 851762, 551319, 100199 and 730661 offer the best-possible potential for exports to Myanmar.

4. Trade Barriers

The Department of Trade within the Ministry of Commerce, Myanmar, oversees amendments to the commerce ministry's list of prohibited imports, as cited in the *2020 National Trade Estimate Report on Foreign Trade Barriers* by the USTR. The list is published in trade bulletins and publications, but changes with little notice.

Thus, businesses looking to export products/commodities to Myanmar need to bear in mind the exhaustive list of prohibited import items for Myanmar: WTO permits members to prohibit the importation of certain articles that endanger public morals, threaten human, plant or animal life,

involve the importation of gold and silver, arms and ammunition, and similar items. The Department of Trade of the Ministry of Commerce, Myanmar, has exercised its rights under these WTO provisions to prohibit the import of the articles mentioned in the current list published by the Department of Trade within the Ministry of Commerce, Myanmar, which include the following:

- Counterfeit money and goods
- Pornographic articles
- Narcotic drugs
- Liquor
- Playing cards
- Drones
- Arms and ammunition
- Antiques and archeologically valuable items
- Endangered species
- Items featuring images of the Buddha, Burma's pagodas and the flag of Burma

In 2019, the Ministry of Commerce developed draft regulations to permit the importation of foreign liquor. Myanmar also requires import licenses to trade in a wide range of products; in May 2019, the Ministry of Commerce released Notification 22/2019 amending Myanmar's Import Negative List, which requires import licenses for 4,613 HS 8-digit tariff items.

Additionally, as mentioned in the *2020 National Trade Estimate Report on Foreign Trade Barriers*, with regards to sanitary and phytosanitary barriers, Myanmar requires additional testing for each shipment of most imported agricultural products upon arrival despite laboratory testing of agricultural products during the license approval process. These testing and inspection procedures are not in alignment with international standards for risk-based inspection of imports, thus posing as a barrier to trade.

5. Concluding Analysis

Myanmar, formerly Burma, is strategically located at the very heart of Asia — bordered by India to the west, China to the east and the ASEAN region to the south. Although endowed with exceptionally rich natural resources, the country was deprived of its economic resources and strengths under the British colonial rule that lasted for 124 years from 1824 to 1948. Even after Myanmar gained independence, the country has had to grapple with extended periods of political instability marring its development. The political class kept the economy in relative isolation, insulating it from global economic and technological progress.

After several decades of economic seclusion, Myanmar embarked on an ambitious reform programme aimed at opening its economy for accelerating economic growth. The gradual economic liberalisation resulted in an uptick in GDP growth, with the economy recording double-digit growth rates of 11.34% in 2000, which further climbed to 13.57% in 2005.

Although the country has experienced a deceleration in GDP growth rate since 2015, it is expected that Myanmar will register a medium-term potential growth rate in the estimated range of 6–7% in the foreseeable future. This re-engagement of Myanmar with the global economy will usher in a rapid phase of industrialisation and deep economic transformations across sectors. Such structural transformations, combined with prudent macroeconomic policies, will enable Myanmar to take advantage of its unique geographic and strategic location developing into a regional manufacturing and logistics hub located between Asia’s two economic powers, viz., India and China.

Bestowed with large hydrocarbon reserves, precious minerals, huge tracts of arable land and an abundant water supply, Myanmar is poised to emerge as key supplier of minerals, natural gas, and agricultural produce to Asia in the coming decades. Besides the physical resource endowment, the demographic endowment in the form of a large and youthful population is also a key factor underpinning the country’s growth potential.

With Myanmar expected to experience rapid growth, the country’s overall infrastructure will need to be upgraded to cater to the growing needs of its urban population. A bulge in middle-class population is expected as capital inflows lead to increasing jobs and incomes. Over time, these middle-class citizens with increased incomes will demand more sophisticated and high-quality products and services. Myanmar’s growth is not just limited to Yangon, but is spreading to secondary cities such as Mandalay.

In view of this altering socio-economic landscape, there is a untapped potential for Indian exporters in this market. While it is pertinent to highlight that India is already a leading exporter to Myanmar for several of its top 25 product imports, the only takeaway for such imported products is that India should maintain its leadership position going forward. For instance in the pharmaceuticals sector, for the product category with HS code 300490, India completely dominates its imports of this product category. A case in point can also be made here for the product category with HS Code 8711110 wherein Myanmar has a very strong imports’ CAGR of 79% for 2014–18 and India has an established strength; imports from India of this category witnessed a surge from US\$ 0.36 million in 2017 to US\$ 8.6 million in 2018, thereby implying that there exists considerable scope for consolidating India’s exports of this product category further.

While this report analyses the import profile in detail, it is important to undertake a deep-dive into each of the potential exports by studying the historical and current market trends, policies, regulations, market share of companies, price trends, infrastructure, logistics, market drivers of sectoral/product growth; assessment of the growth potential of specific product(s)/services for the target segment; identification of external business environment challenges, and; analysis of sectoral developments, evolving policy and regulatory landscape, changing consumer preferences, technology trends, etc., and assessing its implications on market dynamics.
